RESOLUTION NO. 47-2022

Resolution Authorizing Amended Forgivable Loan Agreement with Regional Water

WHEREAS, Chapter 15A of the Code of Iowa ("Chapter 15A") declares that economic development is a public purpose for which a county may provide grants, loans, guarantees and other financial assistance to or for the benefit of private persons; and

WHEREAS, Chapter 15A requires that before public funds are used for grants, loans or other financial assistance, the board of supervisors must determine that a public purpose will reasonably be accomplished by the spending or use of those funds; and

WHEREAS, Chapter 15A requires that, in determining whether funds should be spent, the board of supervisors must consider any or all of a series of factors; and

WHEREAS, Regional Water has proposed to undertake certain improvements and extensions (the "Water Improvement Project") to its water system in order to serve certain property (the "Development Property") situated in Pottawattamie County, Iowa (the "County"); and

WHEREAS, the Water Improvement Project is necessary to provide water service to the Development Property and to promote the development of residential housing thereon (the "Housing Development Project"); and

WHEREAS, Regional Water has requested that the County provide financial assistance in the form of a forgivable loan (the "Forgivable Loan") in order to pay for a portion of the costs of the Water Improvement Project; and

WHEREAS, the County and Regional Water have entered into a certain forgivable loan agreement (the "Original Forgivable Loan Agreement") in connection with the Water Improvement Project and the Forgivable Loan; and

WHEREAS, it is now necessary to amend the Original Forgivable Loan Agreement in order to extend the completion date of the Water Improvement Project and to extend the maturity date of the Forgivable Loan; and

WHEREAS, an amended forgivable loan agreement (the "Amended Forgivable Loan Agreement") has been prepared to set forth the new understanding between the County and Regional water; and

WHEREAS, it is now necessary to take action for the approval of the Amended Forgivable Loan Agreement and to make provision for the execution and delivery thereof;

NOW, THEREFORE, IT IS RESOLVED by the Board of Supervisors of Pottawattamie County, Iowa, as follows:

- Section 1. Pursuant to the factors listed in Chapter 15A, the Board of Supervisors hereby finds and reaffirms that:
 - a) The Housing Development Project, including the Water Improvement Project, will add diversity and generate new opportunities for the Pottawattamie County and Iowa economies; and
 - b) The Housing Development Project, including the Water Improvement Project, will generate public gains and benefits, particularly in the creation of new jobs, income and housing opportunities in the County, which are warranted in comparison to the amount of the proposed Forgivable Loan.
- Section 2. The Board of Supervisors further finds and reaffirms that a public purpose will reasonably be accomplished by making the Forgivable Loan in connection with the Water Improvement Project.
- Section 3. The Amended Forgivable Loan Agreement is hereby approved, and the Chairperson of the Board of Supervisors and the County Auditor are hereby authorized and directed to execute and deliver the Amended Forgivable Loan Agreement on behalf of the County, in substantially the form and content in which the Amended Forgivable Loan Agreement has been presented to this Board of Supervisors. Such officers, and their designees, are also authorized to make such changes, modifications, additions or deletions as they, with the advice of bond counsel, may believe to be necessary, and to take such actions as may be necessary to carry out the provisions of the Amended Forgivable Loan Agreement.

Section 4. All resolutions or parts thereof in conflict herewith, are hereby repealed, to the extent of such conflict.

RESOLUTION DECLARING POTTAWATTAMIE COUNTY'S STANCE AGAINST THE USE OF EMINENT DOMAIN FOR THE CONSTRUCTION OF CARBON DIOXIDE TRANSMISSION PIPELINES.

WHEREAS, Summit Carbon Solutions and Navigator Heartland Greenway intend to construct carbon dioxide pipelines across the state of Iowa, some of which pass through Pottawattamie County, IA.

WHEREAS, these pipelines are for the transmission of captured carbon dioxide gas from various ethanol facilities in Iowa to an underground storage location in North Dakota.

WHEREAS, the only beneficiary of these pipelines will be those producing the carbon dioxide, those transmitting it and those storing it with no contribution to the general public.

WHEREAS, the path needed to construct the pipelines can only be achieved by enforcing Eminent Domain granted by the Iowa Utilities Board across privately held land of opposed landowners.

NOW THEREFORE BE IT RESOLVED, that while Pottawattamie County encourages business growth and development and recognizes the importance of ethanol facilities to the local economy, this particular type of pipeline should not be considered a public utility. Pottawattamie County is opposed to the use of Eminent Domain laws against private landowners as there is no benefit to general public.

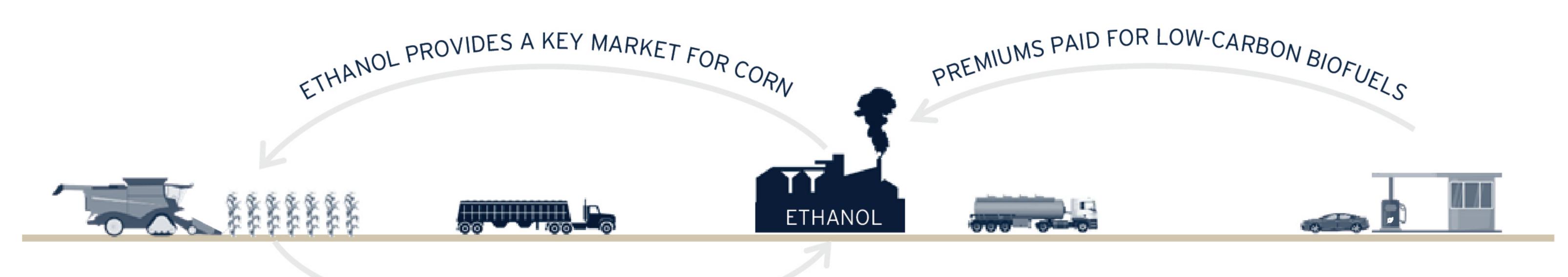

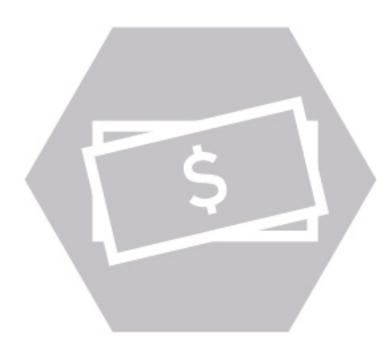

Transporting carbon dioxide by pipeline is the safest method for the large volumes of CO₂ that will be captured and permanently stored. With more than 5,000 miles of infrastructure currently operating in the United States, carbon dioxide pipelines have an excellent safety record.

Carbon capture and storage utilizes longstanding technology that is safe for landowners and communities.

- CO₂ capture is already deployed at more than 40 ethanol plants.
- There are 5,000 miles of existing CO2 pipelines in the United States regulated by the Department of Transportation (DOT) Pipeline and Hazardous Materials Safety Administration (PHMSA).
- Captured CO₂ is permanently and safely stored deep underground based on EPA standards.

Pipelines Are Highly Regulated

Stringent requirements for the safe design, construction, and operation of CO2 pipelines have been established by the DOT PHMSA. Additionally, constructing the Summit Carbon Solutions system requires permits from the following entities:

State:

- Iowa Utilities Board
- Iowa Department of Natural Resources (DNR)

Federal:

- United States Army Corps of Engineers
- United States Fish and Wildlife

Summit Carbon Solutions is working with landowners, community leaders, stakeholders, and more with respect, honesty, and transparency to obtain the necessary rights from the landowners for any proposed temporary and permanent easements.



Summit Carbon Solutions' pipeline will be built beyond federal specifications in these ways:

- PHMSA 195.248 Pipeline Location requires 3ft depth below ground level. Summit Carbon Solutions will be at 4ft minimum depth.
- PHMSA 195.210 Pipeline Location requires 50ft setback from all dwellings. Summit Carbon Solutions is designing the pipeline that far exceeds the minimum setback.
- PHMSA 195.250 Clearance Between Pipe and Underground Structures – Any new pipe must be at least 12" away from any other underground pipe or structure. Summit Carbon Solutions' best practice is 24".
- PHMSA 49 CFR Part 195 defines minimum requirements like the spacing between block valves, which is no more than 20 miles apart and in some cases less for Summit Carbon Solutions' pipeline.

Summit Carbon Solutions will employ a computer based, computational leak detection system that continuously monitors the operation of the pipeline from a manned control center. Similar leak detection systems are currently being utilized in the operation of numerous pipelines across the United States. Data will be continuously collected from pressure sensors, flowmeters, and temperature sensors installed along the pipeline and used to identify abnormal operating conditions. In the unlikely event of a leak, the system will provide information necessary to locate the leak, isolate the pipeline segment, and mitigate risk.

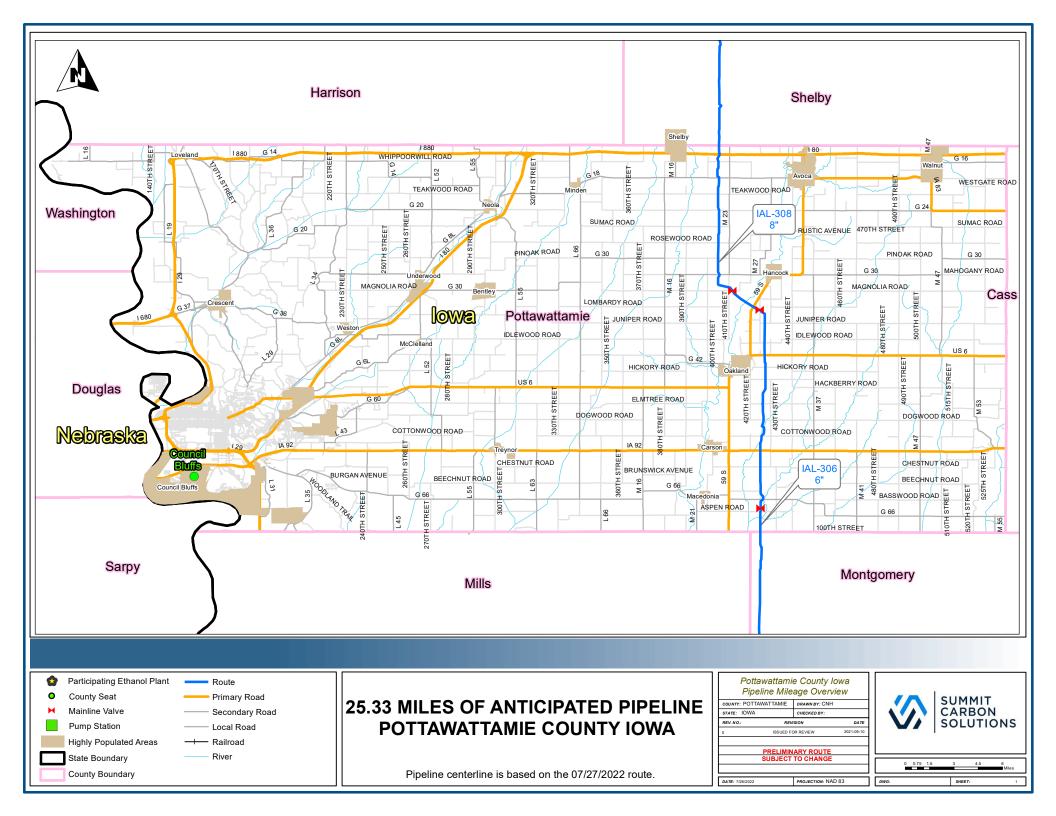

Amended Scope of Work

Scope of Work: Description of the Solution & Mitigation Proposed: To mitigate damages caused by flooding, this project proposes to acquire and demolish/convert to permanent open space 33 total residential properties/vacant lots, with 8 of the properties being active on this application and the remaining 25 properties being inactive/stacked waiting for funding to become available which were substantially damaged due to the flooding of 2019. The project will be implemented in accordance with 44 CFR part 80.

Description of the Proposed Project: Pottawattamie County intends on acquiring and demolishing 8 properties (up to 33) located in the updated special flood hazard area within the unincorporated area. All properties will be demolished using HMGP funds.

Pre-Award: Prior to submitting the application, Pottawattamie County competitively procured/contracted a certified real property appraiser to indicate the pre-flood (March 11, 2019 effective date) retrospective market value opinion of the 33 residential properties to be voluntarily acquired. Procurement was in conformance with the County's procurement policy and applicable Federal requirements. The established pre-flood retrospective market value opinion of each property is the basis of the property acquisition project budget line item. Pottawattamie County also fully procured and contracted survey services in order to separate various acreage properties in which the owner desired to only sell a fraction of the property.

Post Award

Sub-Grant Award: Upon the completion of HSEMD and FEMA application review the application will be approved and the Sub-Grant awarded. HSEMD will be the acting Recipient with Pottawattamie County being the acting Sub-Recipient.

Sub-Grant Acceptance: Once the Sub-Grant is awarded to Pottawattamie County, HSEMD will provide the County with the official grant agreement documentation to be signed and certified by Pottawattamie County Board of Supervisors. This will begin the timeframe for completion of the project to be within 36 months from Sub-Grant award or the grant period end date, whichever comes first.

Administrative Plan: Staff will develop and Pottawattamie County Board of Supervisors will approve an Administrative Plan outlining how the project will be completed including a detailed process for participants to appeal fair market value as necessary.

Historical Preservation: All properties greater than 45 years old have been researched by Pottawattamie County and HSEMD EHP and recommended as having no historical significance to FEMA and SHPO. Both FEMA and SHPO have concurred with HSEMD's recommendation with all concurrence letters attached to this application.

Duplication of Benefits: Prior to official purchase offers being made, insurance information will be gathered from each property owner. This insurance documentation will attest to any proceeds received for structural damage and include any receipts showing repair work completed to the structure since the date of market value determination. This information will then be forwarded to FEMA for the official duplication of benefits determination. Any amount identified as a duplication of benefit will be deducted from the closing amount owed to the property owner and identified on the HUD-1 as such.

Offer to Purchase: Appraisals have been completed and included in this application indicating the pre-flood retrospective market value opinion which will be the basis for the purchase offer amount made by the County to the property owner. If any property transfers ownership post offer then an updated appraisal may be required indicating a revised current fair market value of the property. Once program participants have secured replacement housing or are able to vacate the premises, project management staff will schedule an offer to purchase and coordinate preparation of the offer with the County's attorney. At the offer meeting, the offer and other necessary documents will be executed and a closing date scheduled. No offer to purchase will be extended and closing scheduled unless

the County has a clear 90 day window after closing to accomplish all lot clearing activities without weather conflicts.

Property Closing/Acquisition: The Buyout Administrator, acting as the County's closing agent, will coordinate closing documents with the County's attorney and inspect the property to determine that the owner has removed all personal property. At the time of acquisition, the deed, including the FEMA mitigation model deed restriction language, will be executed and recorded. Future use of the property will be limited to perpetual open space, as defined by HMGP regulations, so that the area can function as natural floodplain. Copies of the conformed documents will be distributed to state and federal agencies as required.

Asbestos Testing/Abatement/Demolition: All properties included on this application will be demolished with FEMA Public Assistance funds. All properties to be acquired will be brought into compliance with the open space requirements identified in the deed restriction within 90 days of acquisition. This includes contracting for and completing testing for asbestos containing materials; abating any identified ACM and household hazardous waste per Iowa DNR / EPA requirements; and disconnecting the attendant utilities including underground water. A trained debris monitor hired by the County will be on site when demolition is taking place. The contractor will have 30 days to complete all abatement and demolition work.

Any demolition taking place between April 15th and September 30th must have IDNR consultation completed prior to demolition taking place to identify any possible adverse environmental affects within the demolition area.

All acquired lots will be deed restricted as open space in perpetuity. The lots will be maintained by the Pottawattamie County. The cost of this maintenance will be included in the County's annual budget.

All costs estimates for services rendered on the acquisition and demolition have all been generated/validated by ongoing acquisition/demolitions within Mills County and Fremont County. These counties are joining, will generate the same bidding contractors, and all are actively acquiring/demolishing properties as a result of the same 2019 flooding. The RFP's and Contracts referenced are on file under the Mills and Fremont Co and can be provided if requested.

In mid-June during steel erection and setting of RTU Roof Curbs, Meco-Henne raised a question about steel support under the RTU's. Verbal conversation was had with M-H and HGM and resulted in submission of RFI #039. The formal RFI asked to confirm if additional steel was required under the RTU's. The response stated the following:

1. IN LIEU OF USING DETAIL 1/S5.4 FOR SUPPORT UNDER THE FULL FOOTPRINT OF AS-9, AS-10, AND AS-11, IT IS PERMISSIBLE TO PROVIDE CONTINUOUS CHANNEL SECTIONS [C6x10.5] TO SUPPORT THE THREE MECHANICAL UNITS ALONG THE LONG LENGTHS OF THEIR PERIMETERS INCLUDING THE LONG SIDE OF THE PIPING VESTIBULES. THE CHANNELS MUST START AND STOP ON A ROOF BAR JOISTS; SO, THEIR OVERALL LENGTHS

It is the contractors opinion that detail 1/S5.4 shows the roof frame openings for duct work coming up in the units and does not address steel support under the footprint of the RTU. Contractor believes the steel that was added under the RTU footprint is above and beyond what is shown in detail 1/S5.4 and is requesting a change order to cover additional costs in steel material and labor.

Estimate detail is included for review.

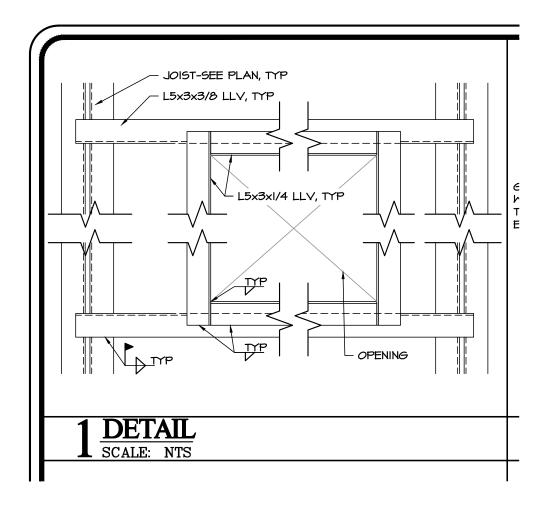

Discussion and/or decision to approve and authorize Chairman to sign Law Enforcement Services Contract between Pottawattamie County and the City of Avoca.

LAW ENFORCEMENT SERVICES CONTRACT

On this 1st day of July, 2022, the incorporated **City of Avoca, Iowa**, hereinafter referred to as "City", and **Pottawattamie County**, **Iowa**, hereinafter referred to as "County", enter into the following agreement to provide Law Enforcement Services.

- 1. <u>Term.</u> The initial term of this Agreement shall be July 1, 2022 through June 30, 2023. Additional one year terms (contract year) beginning on July 1st of each year may be agreed to in writing by the parties. The Agreement shall be reviewed annually in December of the current contract year. If an Agreement is not reached, in whole or part, by the end of December in current contract year, this Agreement shall automatically terminate on June 30 of the following year.
- 2. <u>Services</u>. The County will provide the City with limited law enforcement services by and through the Pottawattamie County Sheriff's Office. These services will include, but not be limited to the following:
 - A. Basic Services. The County shall provide law enforcement coverage when the City of Avoca's Police Department is not on duty. The County does not guarantee any specific hours of patrol, but agrees to respond to all law enforcement calls placed to the Pottawattamie County Communications Department during hours when the City police are not on duty. Follow-up investigations will also be completed by the County when that incident originated with a call taken by the County. The County will also assist the Avoca Police Department with additional investigations when requested.
- 3. <u>Fees</u>. In consideration for the law enforcement services described above, City agrees to pay County as follows:
 - A. Basic Services. City will pay an annual sum of \$21,218.00 to the County. This shall be billed by the Pottawattamie County Sheriff's Office and shall be paid in equal quarterly installments of \$5,304.50 to the Pottawattamie County Sheriff's Office on July 1, October 1, January 1, and April 1.

- 4. <u>Liability</u>. City shall not be required to assume any liability for the payment of salaries, wages, or other compensation for any County personnel performing services under this Agreement, and shall not be liable for compensation for any indemnity to any County employee for injury or sickness arising out of his/her employment, and the County agrees to hold harmless the City against any such claim. The County, its officers and employees, shall not be deemed to assume any liability for intentional or negligent acts of the City, its officer or employees, and the City shall hold the County, its officers and employees harmless there from, and shall defend said County and its officers and employees against any claim for damages resulting there from. The City is not responsible for any act, injury or damage arising out of the performance of this Agreement by the County, and in case any claims are made by any third party, the County shall defend, indemnify and hold harmless City for the actions of the County, its officers and employees.
- 5. <u>Termination</u>. This Agreement may be terminated by either party for any reason. Termination is effective upon a three (3) month written notice to either party, and this shall be accomplished by certified mail to or personal service upon the Pottawattamie County Board of Supervisors at 227 South 6th Street, Council Bluffs, Iowa 51501, or upon written notice to the City Clerk of Avoca.
- 6. Recording. In accordance with Chapter 28E, Code of Iowa, a copy of this agreement shall be filed with the Secretary of State. Signatures will include the Mayor of Avoca, Iowa; the City Clerk of Avoca, Iowa; the Pottawattamie County Sheriff; Pottawattamie County Auditor and the Chairperson of the Board of Supervisors. The City seal shall be affixed to the Agreement before returning to the County for filing.

Discussion and/or decision on employee handbook update pertaining to Sick Leave Donation Policy number 604 item (4).

Title: Sick Leave Donation Policy

Policy Number: 604

Effective Date: July 1, 2009

Revision Date:

Authorized by: Board of Supervisors

Policy:

Eligible employees may voluntarily donate a portion of their accrued sick leave hours to assist another employee with a serious health condition. The purpose of this policy is to alleviate the hardship caused if a serious health condition forces an employee to exhaust his/her paid leave thereby losing compensation. The definition of a "serious health condition" can be found in this manual under the "Family and Medical Leave" (FMLA) policy.

Comments:

(1) This is a voluntary program. Employees shall not be required to donate their accrued sick leave to anyone.

(2) Eligibility:

Full-time employees who have completed their introductory period and who have suffered a serious health condition are eligible to receive donated sick leave if the following conditions are met:

- (a) The employee must have exhausted all of his/her paid leave time including, sick leave, vacation, personal leave, holidays and compensatory time; and
- (b) The employee must either provide or have a FMLA medical certification request on file with the Auditor's Office/Payroll division; and
- (c) The employee has not utilized 480 hours of donated sick leave during their entire employment history with Pottawattamie County.
- (d) Employees on Worker's Compensation or Disability Income are not eligible to receive donated sick leave.
- (e) Donated sick leave may be used for maternity leave for up to eight (8) weeks or as is medically necessary as certified by a medical physician.

- (f) Donated sick leave may be used for the adoption of a child five (5) years and younger for up to eight (8) weeks. In addition, spouses employed by the same employer are jointly entitled to a combined leave of eight (8) weeks of donated sick leave. Donated sick leave may be used for the adoption of a child over the age of five (5) as determined by the Board of Supervisor's on a case by case basis
- (g) Employees are not eligible for sick leave donations in order to care for an immediate family member. Donations may be used solely for an employee's serious health condition only.
- (3) Employees must apply for or be nominated by another employee in order to receive donated sick leave. Employees must complete a "Sick Leave Donation Request" form and shall submit it to the Human Resources Department. If the employee meets the criteria established above, the employee is entitled to ask for donated sick leave. The Human Resources Department does not deny or approve an employee's request based on anything other than the employee's eligibility under the criteria. The employee's "worthiness" or "degree of hardship" is not a factor and will not be considered if the employee otherwise meets the criteria.
- (4) The Human Resource Department in conjunction with the Auditor's Office/Payroll division will maintain a list of employees who have been approved to receive sick leave donations. Unless specified in a collective bargaining unit, an employee may donate to another employee regardless of union affiliation. Employees are only allowed to donate to other employees who are in the same collective bargaining unit or non-union to non-union.
- (5) If an employee is nominated by another employee to receive donated sick leave, that employee shall be notified by the Human Resources Department in order to receive written consent to receive donations. If the employee is unable to provide written consent due to circumstances beyond his or her control, the Human Resources Department will accept donations on behalf of the employee provided the employee meets all other eligibility requirements.
- (6) Employees are limited to receiving a maximum of four-hundred and eighty (480) hours of donated sick leave during their employment with Pottawattamie County.
- (7) Employees may use donated sick leave during the required waiting period under the Long Term Disability Income Plan as long as disability benefits have not begun.
- (8) Employees receiving donations will be paid a maximum of forty (40) hours per work week at their current rate of pay, not the pay rate of a donor.

604:2

- (9) The County will not inform the recipient of the names of those donating hours or the specific number of hours an employee donates.
- (10) If the employee on leave returns to work or separates from employment, any remaining donated leave will be returned to the donors. Hours will be distributed back to the donating employee based upon the date the authorization was received. Last authorization received shall be the first to be reimbursed.
- (11) Donated sick leave may result in additional time away from work by the recipient and as a result, the recipient's Department Head must agree to the transfer of sick leave time. In addition, the Department Head of the employee donating the sick leave will be notified of the donation for the purpose of accurate record keeping.
- (12) Utilization of donated sick leave shall count toward the recipient's FMLA entitlement.
- (13) Employees utilizing donated sick leave shall be considered to be on an unpaid leave of absence and shall not accrue vacation, sick leave or holidays.
- (14) While on donated leave, if the employee is not eligible for FMLA, the employee will be responsible for paying the full health insurance premium, including county contributions.
- (15) The donating employee shall complete the "Sick Leave Waiver & Donation Authorization Form" and shall specify the employee to receive the donated hours. Once a donation has been processed, neither the donor nor the recipient may revoke the transaction. A separate form must be completed for each pay period in which a donation is desired.
- (16) Donations of sick leave must be in whole hours, with a minimum of one (1) hour per donation. An employee may donate any number of sick leave hours so long as the donating employee maintains at least forty (40) hours of accrued sick leave in his or her personal account.
- (17) Terminating employees (including those retiring) may not donate accrued sick leave at the time of separation.

(18) Definitions:

- (a) Serious Health Condition: as defined in the "Family & Medical Leave" policy within this handbook.
- (b) Introductory Period: as defined in the "Introductory Period" policy within this handbook or as defined within respective collective bargaining agreements.
- (c) Long Term Disability Income Plan: as provided for by the county and as defined in the "Insurance Benefits" policy within of this handbook.
- (d) Recipient: A full-time county employee who is eligible to receive donated sick leave.
- (e) Donor: A full-time county employee who is eligible to donate sick leave to another employee.

Thank you for your continued support and participation in the Hungry Canyons Alliance. As of December 2021, 424 Hungry Canyons Alliance streambed structures have been approved for cost share throughout the Deep Loess Region of western Iowa. Pottawattamie County has received approval for or completed 25 Hungry Canyons Alliance streambed stabilization structures with awards and payments totaling \$1,284,044. These structures protect an estimated \$9,317,884 in property value (bridges, farmland, utility lines, etc.). Pottawattamie County has also received \$319,965 in match from the HCA for 25 NRCS-EWP structures. Sixteen private landowner projects in Pottawattamie County have also received a total of \$100,211 in cost share through the Hungry Canyons Small Structures Program.

To date, the Hungry Canyons Alliance has received \$11.94 million from the federal government and \$14.6 million from the State of Iowa. Member counties of Hungry Canyons Alliance have also supported the project, contributing membership fees of \$1,476,250. This strong support allows us to successfully address the problems associated with stream channel erosion in western Iowa. On average, for every \$1 invested in Hungry Canyons Alliance streambed stabilization structures, more than \$4.25 in property value and 0.9 tons of soil are protected from erosion.

To receive funds from Hungry Canyons Alliance, member counties are requested to pay an annual membership fee of \$4,750. Payment of this fee will give you membership in the Hungry Canyons Alliance from July 1, 2022 to June 30, 2023. An invoice is enclosed.

Unless notified, we will assume that Lynn Grobe will continue to serve on the Hungry Canyons Alliance Board of Directors.

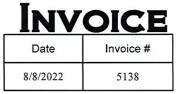
