### **NEW BUSINESS**

- GDX Report Federal Numbers FY23 Pottawattamie County has an approximate Veteran population of 6,224 which is down from 6,351 in FY22 and brings in \$86,597,000 into the County which is up from \$83,261,000 in FY22. Unique patients seen at the VAH is 2,444 which is 12 more than the previous year. Pottawattamie County is 5<sup>th</sup> in the State for Veteran's Population, and 4<sup>th</sup> in the State for \$\$ being brought into the County. Most numbers can be attributed to benefits offered by the county. We are currently fifth in the state for veteran population and fourth for dollars coming into county.
- Commission Public Access (Peggy) A complaint made that there is no direct access to the commission without going through the office. The individual feels that this is inappropriate. The issue was discussed and it was decided that a commission email account will be created and the commissioners will check the inbox prior to the monthly meetings but any emails received will be discussed in open session.
