#### POTTAWATTAMIE COUNTY, IOWA ORDINANCE NO. 2025-01

**AN ORDINANCE** to amend Chapter 8, of Pottawattamie County, Iowa Zoning Ordinance:

#### BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF POTTAWATTAMIE COUNTY, IOWA

**SECTION 1a - REPEAL OF CONFLICTING ORDINANCES:** That section 8.004.095.01 is hereby repealed in its entirety. Furthermore all other Ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent necessary to give this Ordinance full force and effect.

**SECTION 1b - AMENDMENTS**: That the Pottawattamie County, Iowa, Code, be and the same is hereby amended by adding thereto the following new Section, to be codified as Section 8.004.095:

.01 The size of the parcel or lot upon which an ADU will be situated shall be two times larger than the minimum lot size for the zoning *district* in which the parcel or lot is located. Parcels or lots smaller than this requirement may apply for a Conditional Use Permit.

**SECTION 2a - REPEAL OF CONFLICTING ORDINANCES:** That section 8.004.095.03 is hereby repealed in its entirety. Furthermore all other Ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent necessary to give this Ordinance full force and effect.

**SECTION 2b - AMENDMENTS**: That the Pottawattamie County, Iowa, Code, be and the same is hereby amended by adding thereto the following new Section, to be codified as Section 8.004.095:

.03 The minimum total square footage of the ADU shall be not less than two hundred sixty (260) square feet. The total square footage of the ADU shall be subordinate to the principal structure.

**SECTION 3a - REPEAL OF CONFLICTING ORDINANCES:** That section 8.004.095.12 is hereby repealed in its entirety. Furthermore all other Ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent necessary to give this Ordinance full force and effect.

**SECTION 3b - AMENDMENTS**: That the Pottawattamie County, Iowa, Code, be and the same is hereby amended by adding thereto the following new Section, to be codified as Section 8.004.095:

.12 ADUs shall not be allowed on private roads or ingress/egress easements.

**SECTION 4a - REPEAL OF CONFLICTING ORDINANCES:** That section 8.004.095.13 is hereby repealed in its entirety. Furthermore all other Ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent necessary to give this Ordinance full force and effect.

**SECTION 4b - AMENDMENTS**: That the Pottawattamie County, Iowa, Code, be and the same is hereby amended by adding thereto the following new Section, to be codified as Section 8.004.095:

.13 Reserved.

**SECTION 5 - SEVERABILITY:** That should any section or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, that decision shall not effect that validity of the Ordinance as a whole or any part thereof, other than the part so declared to be invalid.

SECTION 6 - REPEAL OF CONFLICTING ORDINANCES: That all ordinance or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 7 - EFFECTIVE DATE: This Ordinance shall be in full force and effect after its passage, approval and publication as provided by law.

#### Memo

To: Board of Supervisors From: Mitchell A. Kay, Chief Financial Officer Date: January 21<sup>st</sup>, 2025 Subject: Utilization of Remaining Urban Renewal Bond

#### Overview

We will be processing one of the final major invoices from Boyd Jones for the Public Health Building. The total amount of this bill is \$435,764.27. The remaining balance of the Urban Renewal Bond will be used to pay \$351,508.08 of this total. These funds were previously used for the Public Health Building but paused to accommodate final courthouse costs. Given that the bond was issued in 2021, it is imperative to utilize these funds promptly.

#### **Summary of Allocation**

- Urban Renewal Bond Funds: \$351,508.08
- Remaining Balance: \$84,256.19 (to be covered by the Land/Improvements Fund 19).

There are a few remaining eligible projects on the courthouse campus, including the parking lot where the annex building was located and the entryway curb, which are planned for later in the spring. Allocating these bond funds now ensures compliance with bond usage timelines and preserves flexibility in the Land/Improvements Fund 19 for future projects.

#### Conclusion

This allocation is within approved budgets of the respective funds and does not require board action. This memo is intended to inform of the plan to allocate these funds for transparency and alignment. The claim will be processed as outlined.
